Green space project, Planit and the working community working group were finalizing the final concept. Due to an overrun on a meeting, I did not attend the lunch hour meeting with the Green Space working group. At the JCCBI meeting we had Discussed the upcoming projects on the Federal portion of the Mercier Bridge. Installation of Saving Lives Signages on the bridge. Discussions with the Capital Unit regarding the Route 207 / 30 interchange rehabilitation project and other planned Infrastructure projects within the community.

On December 20th, I attended the signing of the Statement of Understanding and Mutual Respect between the Mohawk Council of Kahnawake and the Province of Quebec. The signatories were Ohén:ton Í:rate ne Ratitsénhaienhs Cody Diabo and the Premier of Québec François Legault. There was a brief meeting prior to the signing with Premier François Legault and the Minister Responsible for Indigenous Affairs, Ian Lafrenière. Due to this signing event, I did not attend the OCC Christmas Luncheon.

Attend the Iroquois Caucus and AFN in Ottawa from Dec 2-6. Highlights were meeting with our sister communities at IC and discussing how we can build up the IC as the AFN is venturing into areas it is not supposed to so we need to look out for our own interest. As well meet with Minister of CIRNAC which kicked off the Kahnawake-Canada Relations tables. Push for an official apology from Canada for 1990 among other items, such as commitment to continue working on SSSL Land Grievance. Meet with Shadow Minister Jamie Schmale from the Conservative party. Received commitments to a future meeting with Pierre Poilievre in the New year.

Working internally on the "Still Ours Campaign" which is focused on the SSSL. The Launch of this will be early in the new year.

KQR – Kahnawake-Quebec Relations working towards the signing of the MOU with Quebec as well to discuss current files that need to be worked on.

Litigation on the Magic Palace file in its early examination stages. The big news was the signing of the MOU with Quebec. This was years in the making and to get it over the line I proposed very basic language. Again public commitments to work on the outstanding 211 acre debt form Quebec due to the highway 30 construction. A parcel is being suggested however will need to wait for spring before we can continue the required testing on the lot. Looking for other areas as well in the meantime.

The legislative portfolio has approved the carry-over of 3 laws from last term on the legislative agenda. This includes the tobacco law, the residency law and the Kahnawà:ke Operational safety and health.

The Legislative Portfolio team is also reviewing and amending the mandate to be brought before Council for approval. We are also reviewing the Kahnawà:ke Legislative Services structure, constitution, and terms of reference .

Chiefs breakfast is an event where the chiefs cook and serve breakfast for all the MCK staff.

Housing Unit requested assistance from port chiefs in dealing with a handicapped community member in need of emergency home repair. Ryan Montour, Arnold Boyer and myself assessed the situation and provided support to help facilitate the progression of the repair work.

MCK and KSCS collaborated to create an emergency shelter to serve community members who may need temporary emergency shelter. After several meetings we were able to locate and secure a facility. This shelter is now available to use should the need arise. Myself, Ryan Montour and Iohahí:io Delisle have volunteered to be the on-call security for the shelter until a permanent solution is identified.

KMHC Christmas gift presentation was awesome and allowed us to bring some fun to our elders and the hospital what great event for us as well as the residents.



Portfolio Updates for the Month:

December 2024

The month started off with the Council approving the ISC/Kahnawake Child and Family Renovation program. This is the biggest investment for safe and affordable housing and will help numerous community members to build their strong family unit.

Participated in the steering committee with Crown Indigenous relations minister Gary Anandasangaree and the Kahnawake Canada Relations portfolio in Ottawa.

I did not participate in the end of year MCK Friday because I conceded the time slot for the Grand Chief's end of year review.

Under the Justice portfolio, I participated in the eligibility criteria for the selection of Kahnawake Judges in the aspect of regulations. I also participated in the Justice Commission monthly meeting.

Along with numerous other Chiefs, we went visit the patients at the Kateri Memorial Hospital Centre to spread some Holiday cheer.

Under Public Safety, I participated in two brainstorming sessions on solutions for Route 207. The second meeting was regarding non-locals in residential areas. The team consisted of Office of the Council of Chiefs, Public Safety Commissioner, MCK Transport Coordinator. We are in the process of implementing short term measures that will effectively deal with community concerns.

The end of the month concluded with more exciting news from the Housing department. We have raised the On Reserve Loan Guarantee to \$400,000 thru the local Caisse Popular, we also have approved the application for more section 95 Housing for the building of six units (tiny homes/six plex). Also, we have approved the reconciliation task force to deal with the victims of Fraud and Elders to be at the top of the list. There have been up to 500k approvals in write offs that will be applicable.
