As per Kahnawà:ke Legislative Coordinating Commission (KLCC) requirement, the KLCC requested that this Law be repealed, as it had not re-entered the regular Community Decision Making Process (CDMP) within the required time after passage using the Urgent Process of the CDMP. Additionally, as part of this Resolution, this Law will be immediately submitted by Grand Chief to the KLCC to be installed on the legislative calendar. The Motion passed, with Clinton Phillips abstaining.
