#### **Discussion/Request for Decision: Peacekeeper Services Board (PSB) issues of jurisdiction and lack of regulations for Security Firms in Kahnawà:ke**

PSB will send letters to the private security firms advising them of today's discussion with Chief & Council, the mandate given to develop regulations and actions taken to inform the community on these matters.
