#### **Request for Decision, Mohawk Council Executive Directive: Replacement of Voting Member of Tioweró:ton Committee**

Due to Eva Johnson stepping down as Coordinator of Kahnawà:ke Environmental Protection Office, she is hereby replaced as a voting member of the Tioweró:ton Committee by Debbie Morris. Mrs. Morris, as General Manager of Lands Services (who is now responsible for coordinating KEPO operations), will replace Ms. Johnson on the Committee. Passed unanimously.
