

Portfolio Updates for the Month:

January 2025

Justice portfolio: Reviewed governance documents pursuant to the Regulations for Kahnawake Judges; discussed funding for Justice Services, specifically for Ionkwatahonhsate (Victims of Crime) and Skén:nen Aonsón:ton; joint meeting held between Justice Portfolio Team and Legislation Portfolio Team to discuss unit mandates and align structures. Monthly Justice Commission meeting held. Agenda items were the review of the governance documents for Judges and Justices of the Peace, update and stats presented for victim services and Skén:nen Aonsón:ton services, overview of Justice Services mandate and update on the status of the request for a land designation for a community justice center.

Governance portfolio: Final details discussed regarding the governance advisory group and the consultation on the governance documents. KTV segment filmed to launch the call out for community members interested in being part of the advisory group. Discussed the need to create policies and procedures for appeals to the Finance Administration and Operations Committee (FAO) and for appeals to the Council of Chiefs. Special working group to be formed (representatives from Legal Services, Justice, Executive Office and Governance Portfolio Team members) and meeting to be scheduled.

Cannabis file: Briefed new Operations Manager for the Cannabis Control Office on the Cannabis Health and Safety Committee.

Meeting with the Committee and the Board to be scheduled as soon as possible. General update provided on stage of the dispensary license process.

Administrative Affairs Portfolio: Revision of a number of internal administrative policies being conducted (Education Leave Policy, Salary Administration Policy). Identified and discussed work to be done on formalizing the relationship between the Chief Political Advisor (CPA) and the Executive Director (ED). Discussion on the idea of an Administrative Liaison to provide administrative oversight to the offices responsible for regulatory boards and commissions.
