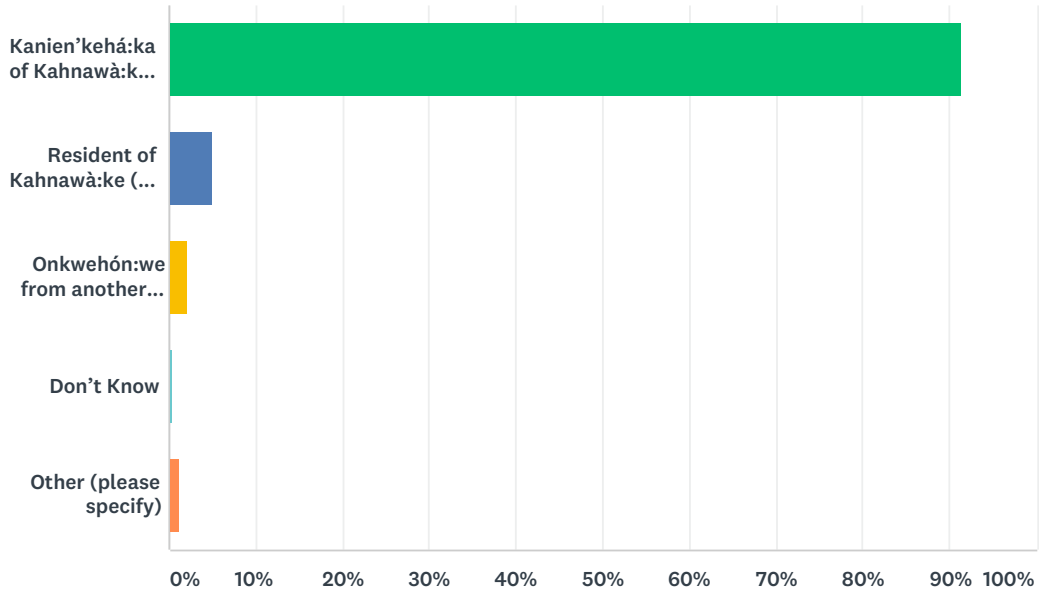


Q1 Which of the following best describes you?

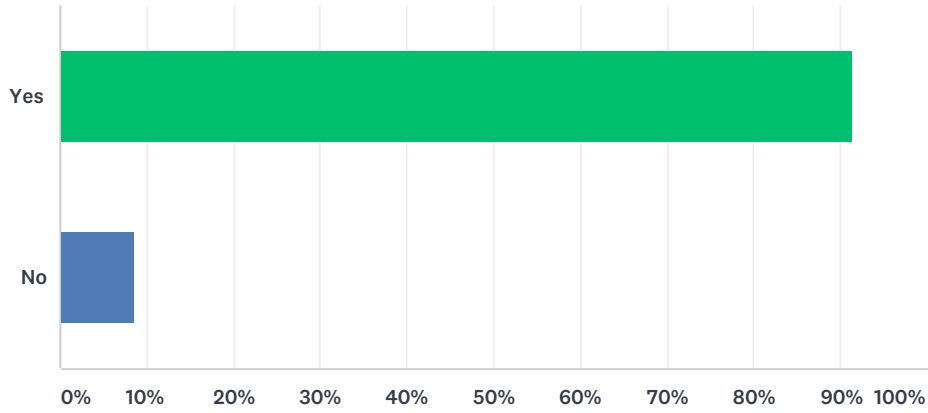

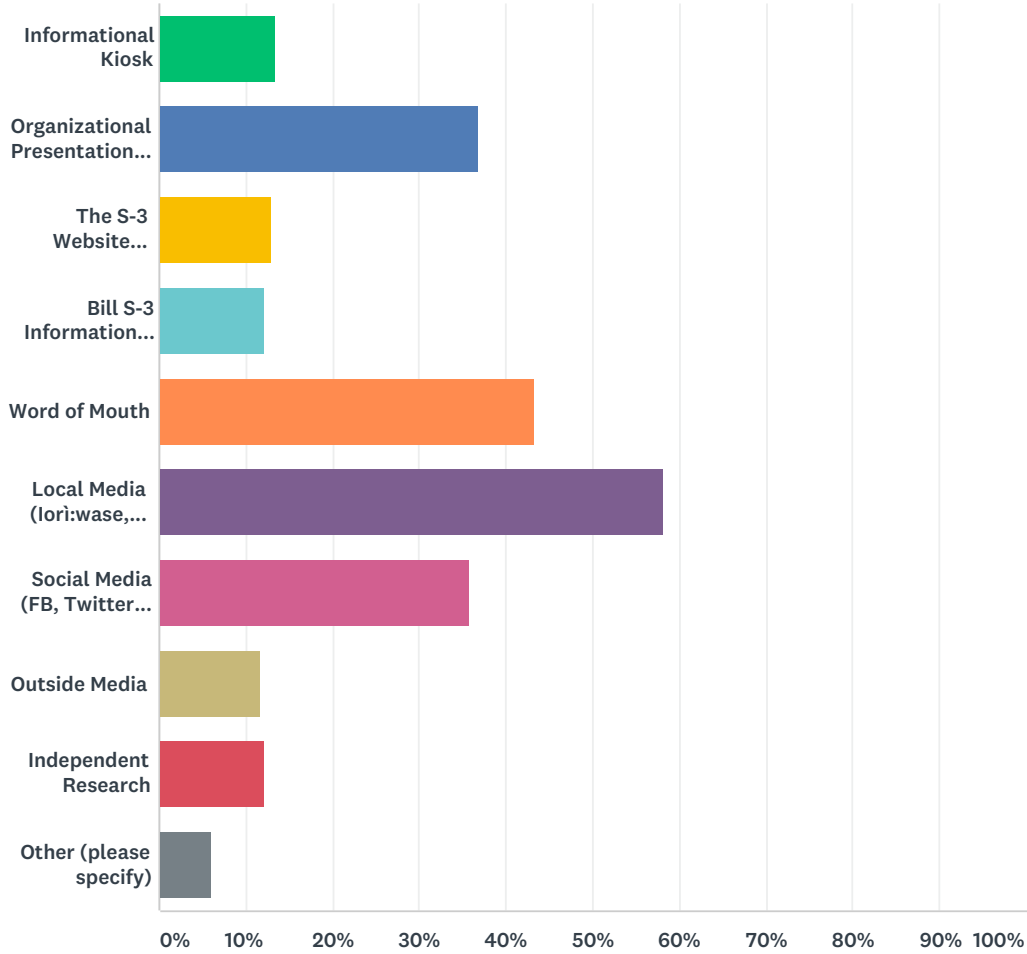

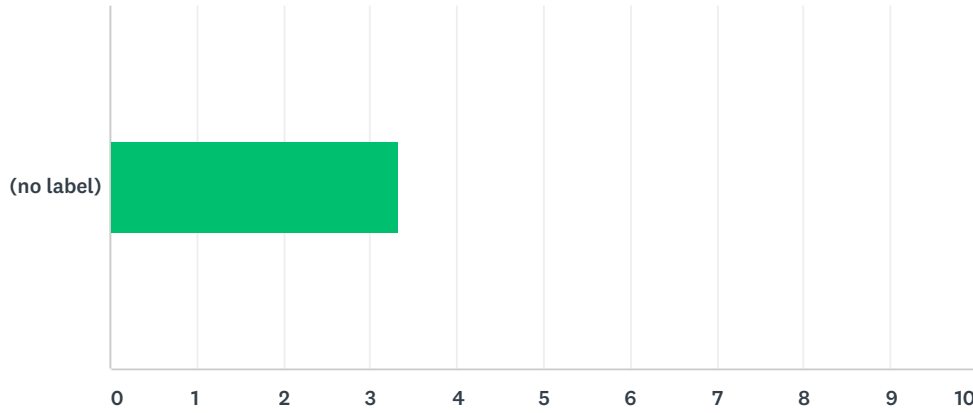

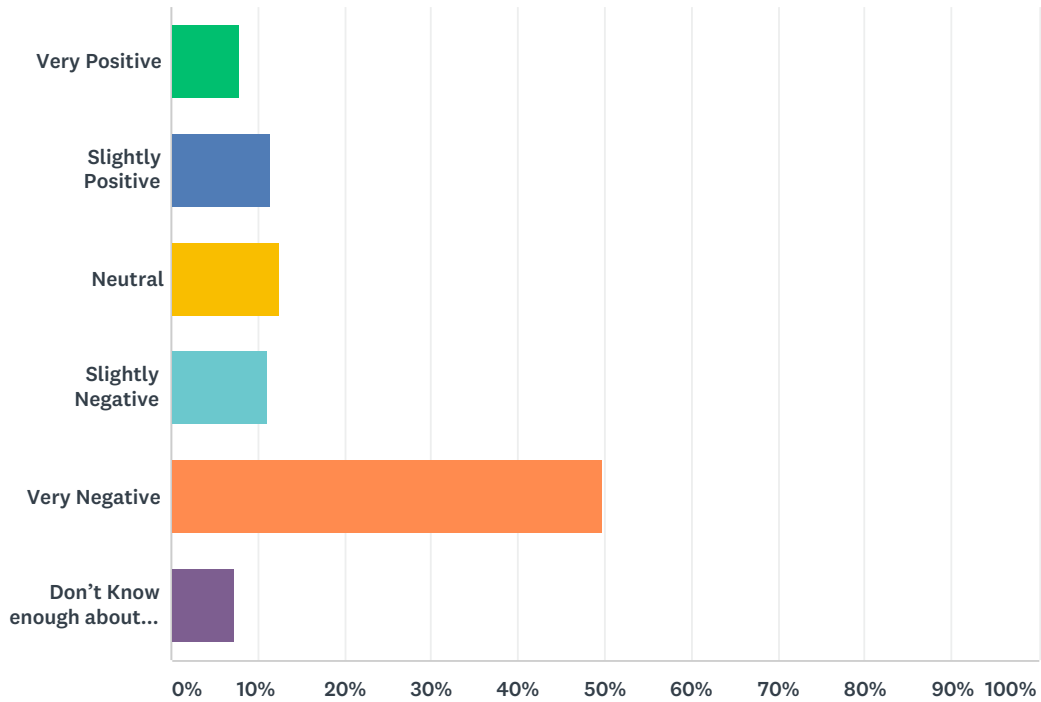

Q5 Do you think that the removal of the “1951 cut-off” from the Indian Act is a positive or negative thing for Indigenous Peoples? Choose one.

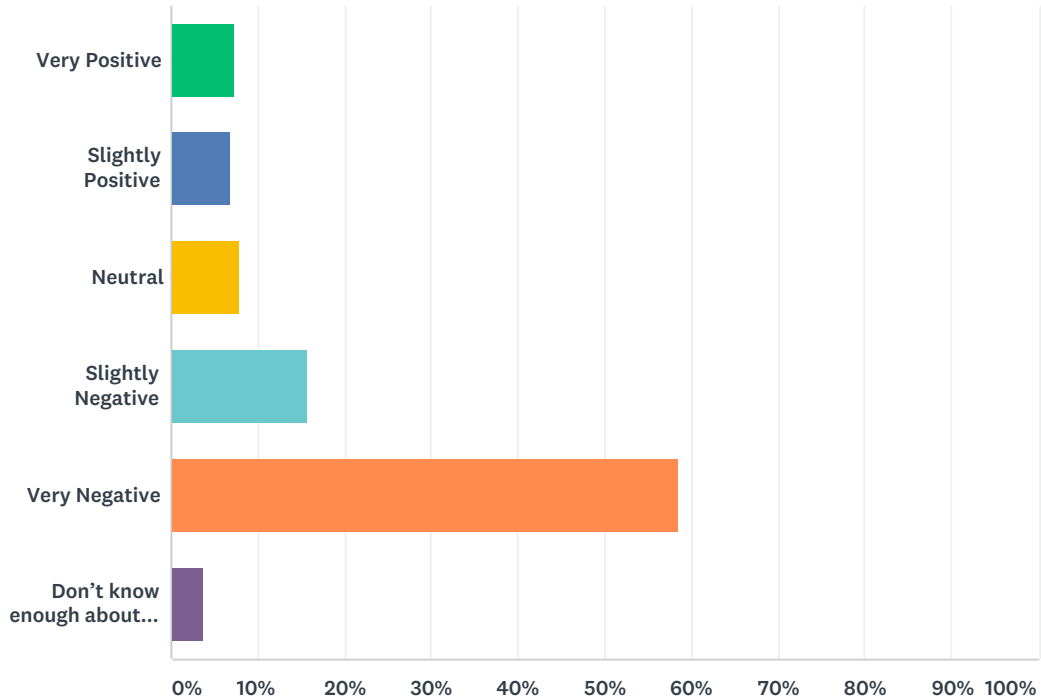

Q6 What do you think of the possible results to Kahnawà:ke (population growth) of the Canadian government attempting to right the wrongs of gender-based inequalities?

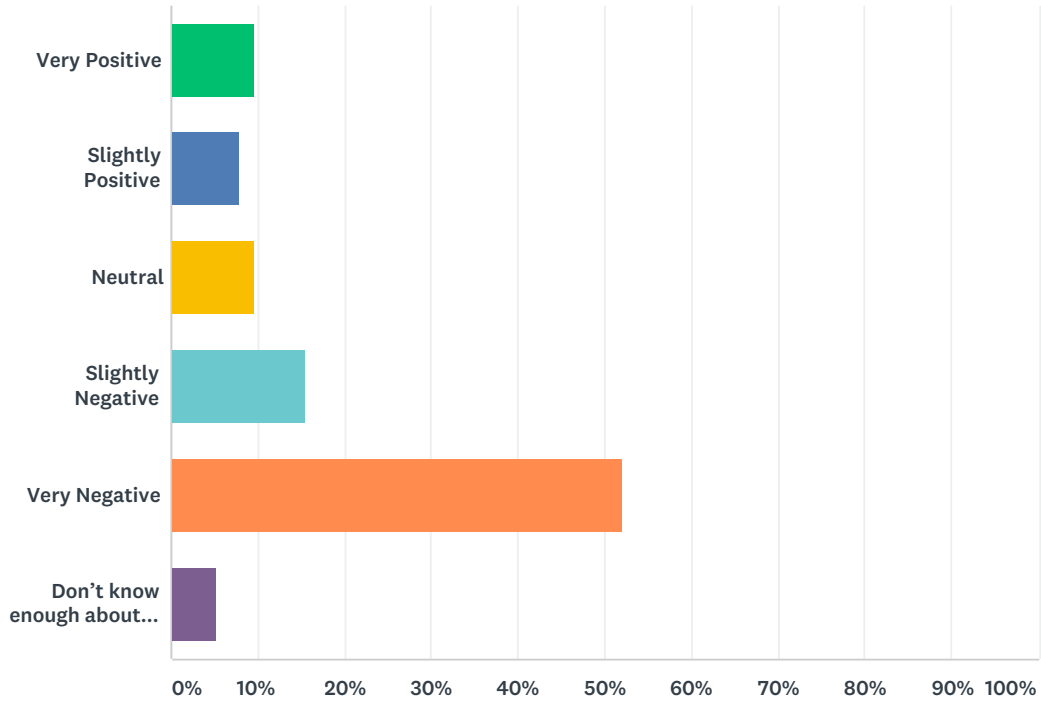

Q7 What do you think of the possible results to all Onkwehon:we people (population growth) of the Canadian government attempting to right the wrongs of gender-based inequalities?

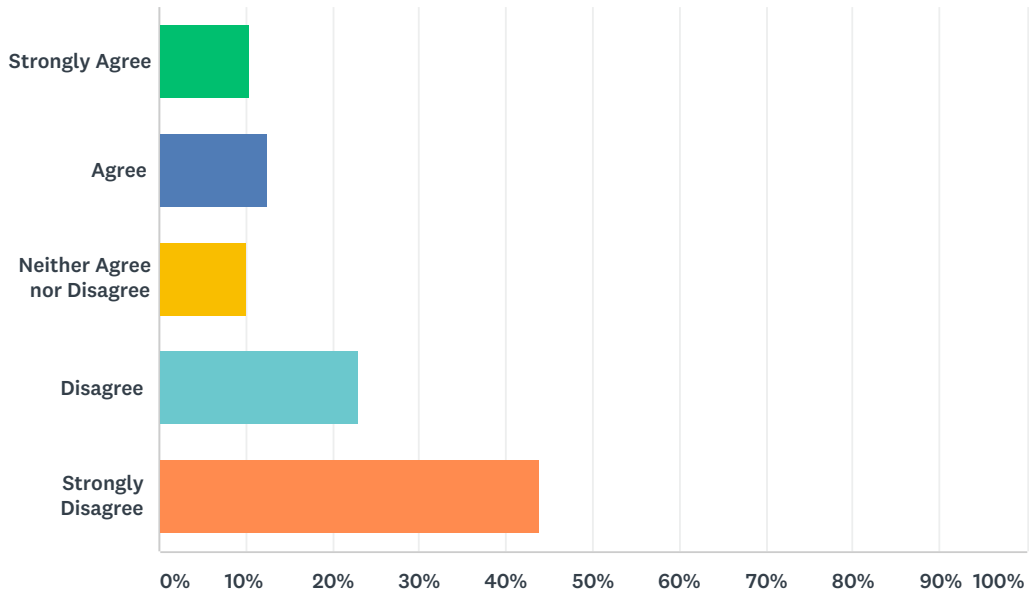

Q8 Do you agree with the fact that Indigenous communities throughout Canada are being taken to Canadian courts over membership issues?

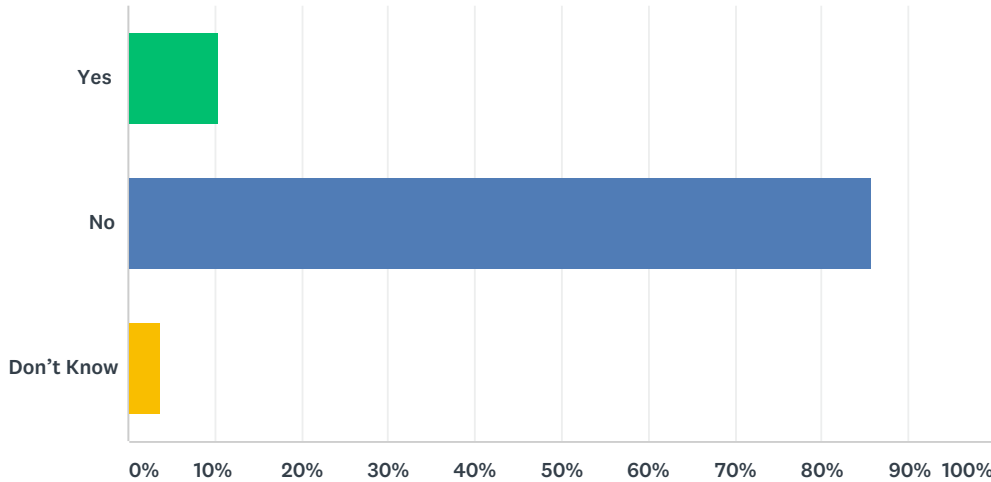

Q9 Do you believe that it is appropriate for the Federal government of Canada to be discussing issues over Indigenous membership and citizenship?

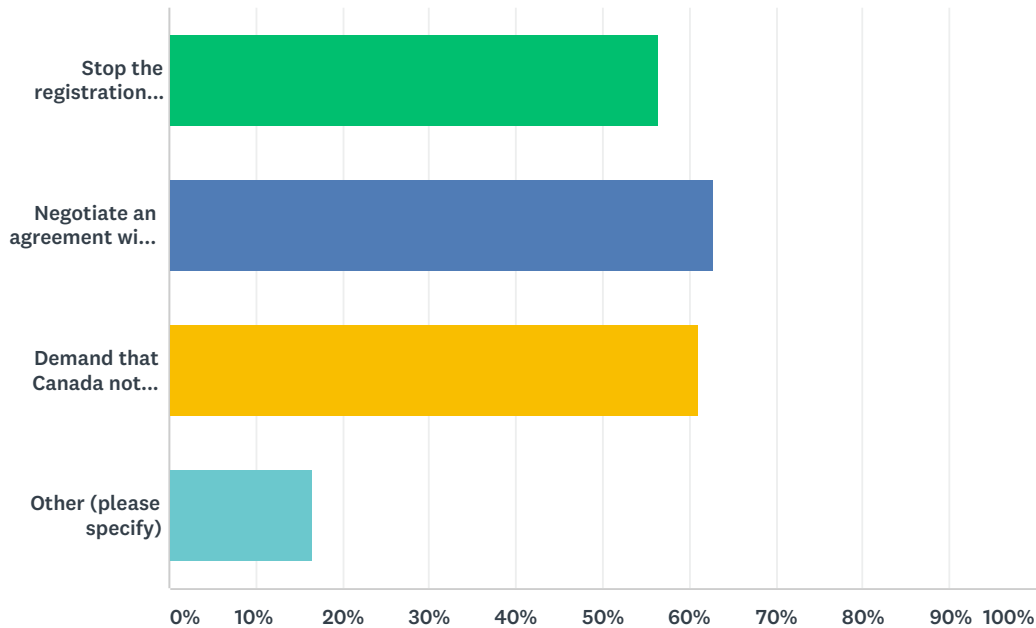

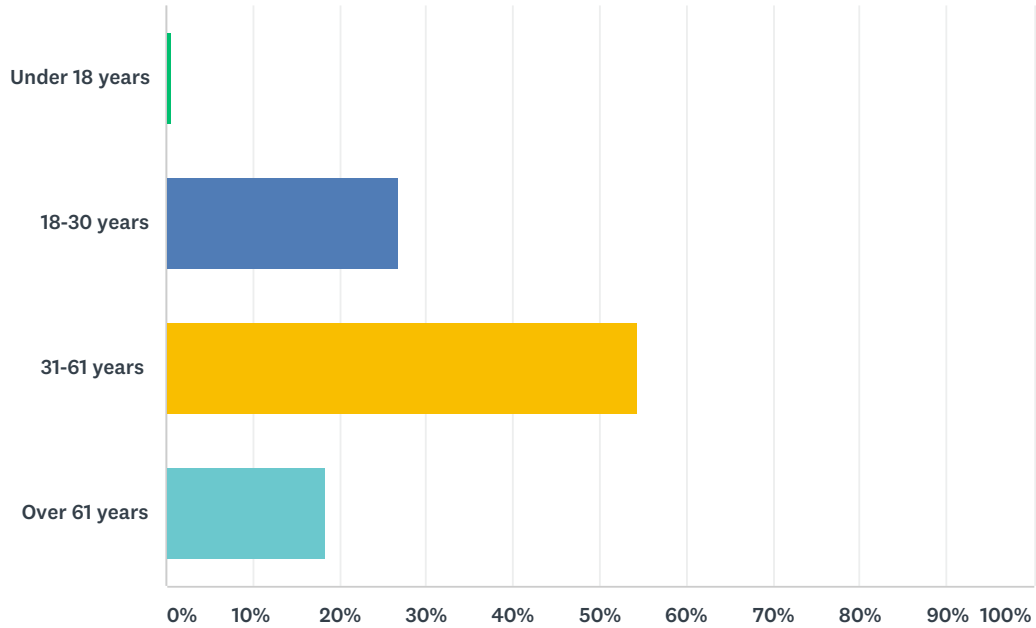

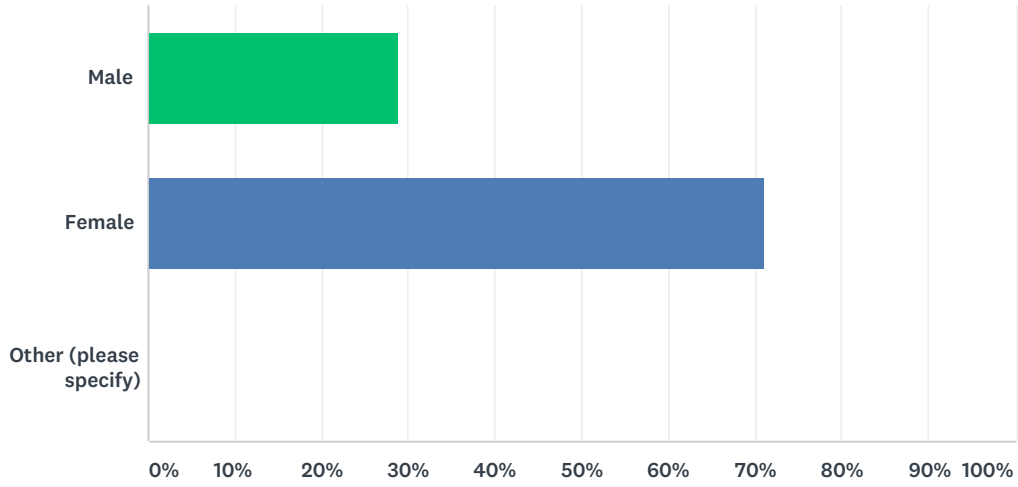
