# <u>Mohawk Council Executive Directive: Funding for Special Needs Students - Jordan's Principle Issue</u>

Presence of Kahonwentha Stacey (Office of the Council of Chiefs Project Leader). Portfolio Lead: Ohén:ton Í:rate ne Ratitsénhaienhs Cody Diabo, Portfolio holders: Nitsénhaienhs Jeffrey Diabo and Ross Montour. Request to approve a one-time payment to cover the balance of school tuition for twenty-five (25) special needs students, as a result of delays from funding through Jordan's Principle. The funds would cover the remaining tuition costs for the 2025-2026 academic year, totalling \$325,754.85, on the condition that the amounts are repaid from Indigenous Services Canada by end of fiscal 2025-2026. **Passed by consensus.**
