The Kahnawà:ke Search and Rescue Operation took place in Ganienkeh during the first week of August. As an active team member, the team was successful in helping our sister community on locating a 14 year old missing person.

I participated in the Trauma Informed Workshop all week, was present during the community protest showing support for our local Peacekeepers.

Participated in 3 community Kiosks regarding Hot Mix Asphalt Regulations. I Received feedback on over 90 percent of community members and provided feedback to the TDC.

Participated in Peacekeepers Services Board Meetings throughout the month of August, in working towards better management and administration of the Peacekeepers.

During the housing reconciliation meeting we provided moral support to existing housing clients and also provided clear communication opportunities.

I also participated in the KCR meeting in the last week of August. Setting up sectoral tables and securing 5-million-dollar land funds to be administered by KEPO and the Land Unit.

## Portfolio Updates for the Month:

#### August 2025

NOTE: Missed the deadline for the <u>July report</u> so will provide it here. Took 7 days of vacation in July and 1 day of wellness. Attended annual 5 day session of The Expert Mechanism on the Rights of Indigenous Peoples that took place at the UN in Geneva, Switzerland from July 11-19. Also, attended the training session on the preparation and submission of a statement. This body assists member states in achieving the goals of the United Nations Declaration on the Rights of Indigenous Peoples and conducts studies to advance the promotion and protection of those rights. Revised application and privacy waiver for Judges and Draft Regulation for Disciplinary Measures for the Decision Makers of the Administrative Tribunal. Discussions with Justice Services regarding the Community Justice Center building and location. Package being prepared for Council.

August JUSTICE: Discussions and work with Justice Services regarding drafting and finalizing of governance documents for Justice of the Peace (Code of Conduct, Oath of Office, Confidentiality, Terms of Reference and Recusation. Addressed issue of Justice/Judge to hear requests for eviction orders. Obtained approval for request for land designation for the Community Justice Center. Site prepared began (site located across from Quarry next door to Animal Protection Unit). Early 2026 projected for delivery of the modular unit.

GOVERNANCE: Draft Code of Conduct finalized and posted for 30 day review. Dates for two community kiosks set. Communications plan developed. Continued reviewing the Terms of Reference for Council Chiefs with the Governance Advisory Team.

CANNABIS FILE: KCCB remains defunct. No applicants for the Board. No further developments to report on my end. A working group led by the Grand Chief has taken on the responsibility of finding an alternative solution to the functioning of the regulatory regime.
