SHORT-TERM RENTAL HOUSING PROGRAM

The Short-Term Housing Rental Program (STRHP) is intended to house Kahnawákeronon who require short-term housing. The program is intended to provide temporary, safe, and affordable housing for Kahnawákeronon in emergency situations.



ELIGIBILITY

- * Must be on the KKR
- * Must be facing an emergency housing situation

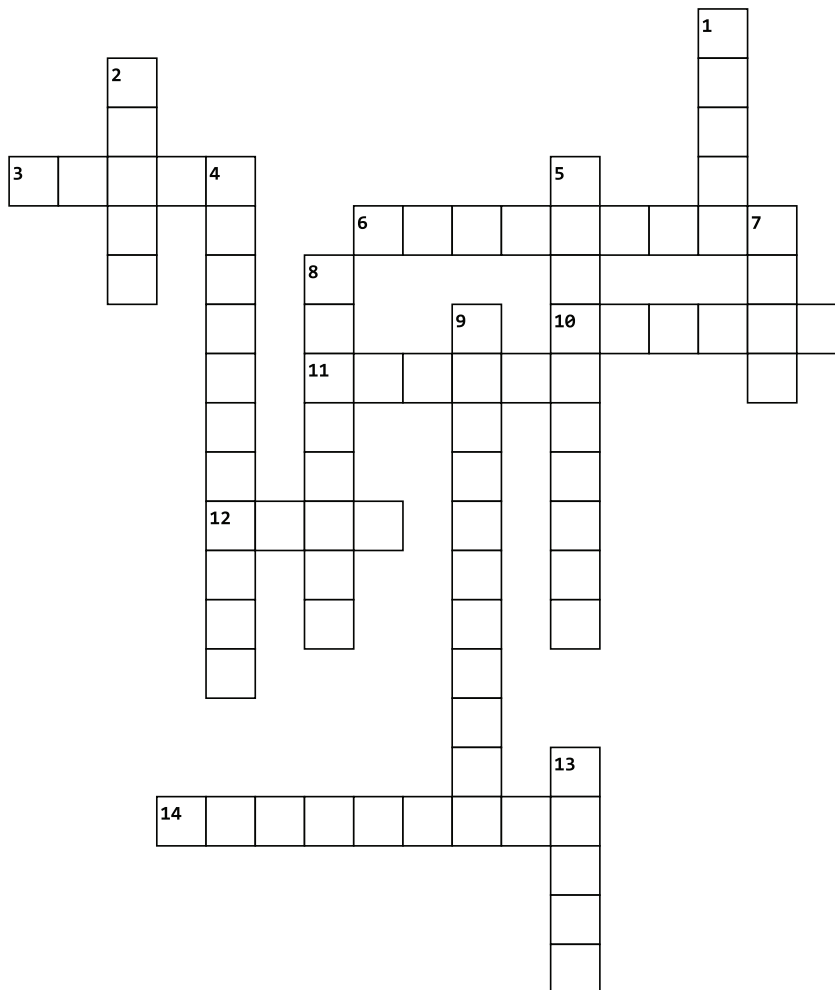
